PARADE RULES & SAFETY PRECAUTIONS

No entry fee. **NO RELIGIOUS OR POLITICAL HANDOUTS ALLOWED!**

No articles to be thrown from any float/vehicle during the parade. Items and/or goodies may be handed out by someone delivering them to spectators.

The participants acknowledge that the City of Trail, Silver City Days Planning Committee, their employees, associates, members, and volunteers will not be carrying out any inspection to ensure compliance with parade rules or any safety requirements. Safety remains with the participants. Vehicles must not leak oil or fuel.

All entries must be decorated and have a name sign.

RELEASE FORM

In consideration of the City of Trail and the Silver City Days Planning Committee permitting participation in the Trail Firefighters Association/Silver City Days Parade, I hereby agree as follows:

3. TO HOLD HARMLESS AND INDEMNIFY THE RELEASESEES from any and all liability for property damage or personal injury to any third party resulting from participation in the event;
4. THAT THIS RELEASE OF LIABILITY shall be effective and binding upon the participant, heirs, next of kin, executor, administrators and assigns in event of death.
